

Brief History

- 1972 In December opened Yours in Travel Personnel now known as Yours in Travel Group. Targets were: American Express, Thomas Cook, Liberty Travel/Gogo Tours, and Alexanders Travel. All signed our recruitment contract.
- 1973 Opened 2nd office overseas in the U.K.

First personnel agency to offer Mastercard and VISA to pay fees.

1975 Two years later opened P. Jason King Associates, Inc.

Opened Executive Search - Management & Senior Management for the Travel & Hospitality Industries, simultaneously opened Consulting Services Division, serving same client base in M&A (Buying & Selling) of Travel Companies. Our Consulting division provided Marketing, Advertising & Promotion, Special Events & Public Relations.

- 1979 The King Group was established as our umbrella company.
- 1983 Opened Special Events Etc., Inc. At its peak, ran 1,000 events per year, Including the opening of Walt Disney's "The Lion King" in NYC with 1,700 guests. Other events included Murder Mysteries, Million Dollar Wedding, Awards Banquets, Corporate Meetings and more.

Created and developed "The Party" – a celebration for the Travel Industry, over 1,800 attended including government dignitaries and Travel Industry Icons.

Consulting Division provided Ratings & Evaluations for Travel Companies. (This was the beginning of what is now GuestGhosts.com) 1985 Initiated solicitation with Ask Mr. Foster in Van Nuys
California, with VP Finance Mr. Sandy Kagan, couldn't
do any recruitment work, direction changed and
"Brokered" the sale of a 16 Branch Travel Agency
Chain, in Alexander's Department Stores in NYC,, with
Chairman of Alexander's, Mr. Robin Farkas. Note: We
held an exclusive contract for all recruitment of
Alexander's Travel. We placed CEO (Andrew Marti) to
Travel Advisors. Executive Director was Mr. Irwin Rich.

First personnel agency to be online with SABRE.

- 1990's At this time, we owned and operated 28 offices (USA & overseas). All offices wholly owned.
- 1993 Created and developed "Vacation Expo '93" a
 Consumer & Travel Show with the first Travel Agents
 with GDS allowing the attendees to book their vacations
 on the floor. We had 53,000 pre-registered attendees,
 and over 300 Suppliers.
- 2001 Due to 9/11 changed our business modules from offices to virtual, and our emphasis from corporate to leisure.
- 2010 The King Group Companies developed a global network of offices and representatives.
- 2011 The King Group Companies continued to grow.
- 2013 GuestGhosts.com com re-born re-named and re-launch Mar. 13, 2013. Due to the untimely death of Richard Knott, a Partner, we ceased operation.
- 2019 COVID changed the World and how we conduct our businesses. We had been working with M&A for quite sometime. We immediately created TravelMatchmakers.com to assist Travel Companies with their options for Buying or Selling, Partnerships, and VC/PE Funding. Also offered Free Advice to all.
- 2023 GuestGhosts has been reactivated with higher technology and enhanced systems and procedures.
